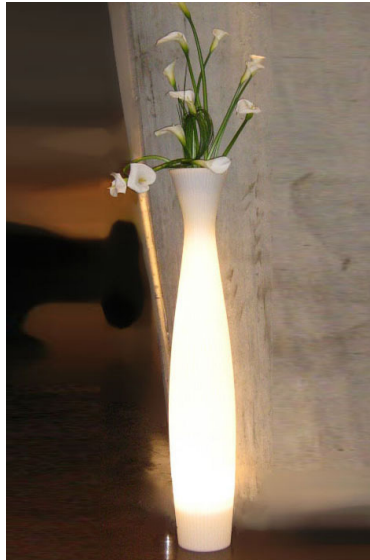

## RENTAL CONDITIONS

**Order: Prices (before tax) are only valid for the duration of an exhibition or a show in the Paris Area.** These prices include delivery, assembly, dismantling and maintenance depending of the exhibition duration. **All orders placed by the Customer must be set forward in writing.** In the event of a complaint regarding our services, the Customer must send to the Company a fax or letter within a time limit of 48 (forty-eight) hours. In the event of a request regarding the invoice, the Customer must send to the Company a registered letter within a time limit of 72 (seventy-two) hours following the receipt of the invoice. In case of a shortage of supply for the type of goods or the size of goods indicated in the order, the Company reserves the right to replace them by the closest alternative type of goods. All rented goods are delivered to the Customer in perfect condition. Once the delivery of the rented goods has been made to the Customer, the Customer shall be responsible for them until the full dismantling by the Company itself. Consequently in case of theft or damage, the Customer will be charged for the items concerned based on the selling price of these items. Variations due to the flowering cycle of our goods can make the Company modify the composition of the plants and/or flowers proposed, the price remaining the same.

For all orders outside Paris or abroad, please contact us.

**Delivery:** The exact position of the stand must be clearly written on the order in order to help delivery. The delivery, the maintenance and the dismantling of the order is the responsibility of the Company in the case of an official exhibition. The Customer order will be considered as safely delivered once the Company has made delivery on the stand indicated by the Customer. In case of a delivery made after the official opening of the exhibition, on Sunday, public holiday or out of opening hours, an additional cost may be charged by the Company.

**Customer Liability:** The liability of the Customer starts from the time of the delivery on the stand (even if the Customer has not yet taken possession of the stand) until the full dismantling by the Company. Any dispute shall come under the exclusive tribunal of the Versailles Court.

**Use - Damage - Non-return:** The Customer undertakes to use the rented goods with care and in an usual way. As from Delivery Acceptance, the Customer shall be responsible for any damage caused to the rented goods. In the event of damage or non-return of the leased goods, the Customer shall pay the amount of the full replacement value of the goods, together with a compensation covering the non-availability of the equipment.

**Reservation of title - "Réserve de propriété":** Except with regard to the lease of goods, in which case the goods do not cease to be the Company's property, the goods sold shall fully remain the Company's property up until full payment of the price in principal and incidental expenses.

**Act of God - "Force Majeure":** The following events, without this list being exhaustive, shall notably be treated as Act of God events: natural disaster, bad weather, shortage of raw materials, fire, flooding, earthquake, strike, production blocked by workers interfering with the preparation or performance of the Contract, interrupted and/or delayed carriage, power failure, embargo, trade ban, sabotage, operation by the civil or military authorities, acts of war, declared or undeclared hostilities, terrorist attacks or riot.

In the event of Act of God, the Company shall be released from its obligations and shall not incur any liability due to any reason whatsoever.

**Specific conditions:** For all order made within less than 5 days regarding the delivery date, an extra charge of 10 % will be applied on the total amount (before tax). For all demand regarding a delivery or a dismantling of an equipment by a specific time, an extra charge of 10 % will be applied on the total amount (before tax).

All waiting time not specified in the order, on delivery or on dismantling, will be charged at the hourly rate in effect. The total or partial cancellation of the order shall entail, regardless of the timeframe in which it takes place, the payment by the Customer of a sum representing at least 50% of the total price (before tax) without being less than the total amount of the expenses already incurred at the moment of the cancellation. In the event of cancellation less than 72 (seventy-two) hours before the delivery, the price stipulated in the order shall be paid in full by the Customer.
